



WAIVER AND RELEASE OF LIABILITY
(the "Agreement")

In return for being allowed to participate in the NFL FLAG National Tournament of Champions to be held on November 15-18, 2007 at Disney's WIDE WORLD OF SPORTS ® Complex and all related events and activities, including but not limited to, activities that take place at other Disney properties, and any qualifying rounds for such tournament held within other cities or locations (the "Event"), I release and agree not to sue the National Football League (the "NFL"), its member professional football teams, NFL Properties, LLC, NFL Ventures L.P., NFL Enterprises, LLC and their employees, subcontractors, sponsors, agents, and affiliates, and each operator and owner of the respective venue locations (collectively the "Releasees") from all present and future claims that may be made by me, my family, estate heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation in the Event and related activities wherever, whenever or however the same may occur. I understand that and agree that those listed above are not responsible for any injury or property damage arising out of the Event, even if caused by their ordinary negligence. I understand that participation in the Event involves certain risks, including but not limited to, serious injury and death. I am voluntarily participating in the Event with knowledge of the danger involved and agree to accept all risks of participation. I also agree to indemnify and hold harmless the Releasees for all claims arising out of my participation and related activities including but not limited to, transportation to and from the Event. I agree that without any further consideration from the Releasees, to grant the Releasees the unlimited right throughout the world to use my name, nickname, image, likeness, voice, photograph, signature facsimile, and biographical information in any media now or hereafter existing in perpetuity. I understand that the NFL will only provide airfare/travel if a NFL FLAG tournament participant travels with their team, using only transportation services provided by the NFL. I understand that this document is intended to be as broad and as inclusive as permitted by the laws of the state in which the Event is taking place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings related to this waiver will take place in New York, New York.
